#### **JOB SUMMARY:**

This is a safety-sensitive position in the Department of Engineering, functioning as a front line provider of services in performing a variety of semi-skilled and skilled tasks necessary to construct, repair and maintain Town stormwater facilities. When assigned by the Stormwater Supervisor individuals in this classification will also assist the Parks, Fleet, Traffic and Streets Maintenance Divisions within the Town.

#### **ESSENTIAL QUALIFICATIONS:**

Must be 18 years of age or older with a high school diploma or GED equivalent. Valid Colorado, Class A, Commercial Driver's License with air brake and tanker endorsements and a good driving record or the ability to obtain within six (6) months of employment. Traffic Control/Flagger Certification or ability to obtain within six (6) months of employment. A combination of education and experience to provide for the necessary knowledge, skills and abilities. Working knowledge of equipment, materials, techniques and supplies used in the maintenance of Stormwater Facilities. Ability to work in small and/or confined spaces. The ability to successfully complete a background check including but not limited to: criminal history search, motor vehicle record (MVR) check, DOT drug screen and physical examination is required.

Tech I: One (1) year of labor experience or six (6) months of agency experience in stormwater maintenance or a closely related field. Current NIMS/ICS training through IS 100 and IS 200 or the ability to obtain upon hire.

Tech II: One (1) year of experience within the Town of Parker or two (2) years out of agency experience in stormwater maintenance or a closely related field, required. Current NIMS/ICS training through IS 100 and IS 200 or the ability to obtain upon hire.
