- She provided a brief update on the schedule for the CRS Program reform
  - i. Revised CRS Program Implementation December 31, 2027
  - ii. Final Actuarial Report published September 30, 2025.
    - 1. Loss levels spending v payments
    - 2. How much are the policy amounts effecting the program
  - iii. The new program will only credit activities that reduce flood risk.
- b. CRS 450 Watershed Master Plans MHFD is looking at these again for CRS credit
- 8. News from ISO (Kerry Redente)
  - a. ISO/FEMA coordination meeting in April, Kerry will have more to report afterwards.
  - a. Online submittal tool—she requires all communities to use and pointed out the uploaded documents remain in the system for future reference.
  - Freeboard reminder—floodplain management regulations need to require machinery and equipment to be elevated in addition to the structure; issue ISO is finding in other states; not typically a CO issue..
  - CRS not much to report at this moment.
    - New year, schedule 2024 cycle verification visits
    - Reach out to request dates if needed.
  - d. Q: are communities trending up or down?
    - i. Most are staying in class or improving. Few retrogrades. Colorado communities are good.

- II. (Pat) Jefferson County – couple hundred reduction in policies
- III. Kim Pirri – we are seeing policies going down too.
- IV. Jennifer Waters – Estes Park down to 150 policies from 200 two years ago.
- V. Jeremy – FEMA says that they are seeing reductions nationwide

# 9. Discussion Items/Future plans:

- a. Community Assistance Visit (CAV)
  - i. Not the same as a CRS Cycle verification visit
  - ii. Region 8 Team—Marijo Brady, FEMA CRS Regional Coordinator, explained CAVs are a review of the implementation and administration of community's floodplain management program.
  - iii. CAVs are conducted by the CWCB or FEMA—one agency takes the lead.
  - iv. The Community Assistance Program—State Support Services Element (CAP-SSSE) is a State grant to help deliver the NFIP at the local level.
  - v. Marijo described the Community Assistance Contact (CAC) as a screening conversation, a tool to identify community training needs or CAV, etc.
  - vi. July 1st 2025 new process called an "audit." Supposed to be a faster process. Similar to current process. More definitive results.
    - 1. Trainings will be offered
  - vii. No anticipated CAVs in FY 2024 or 2025, Want to close old CAVs during that time and get the audit process introduced
  - viii. Examples: Denver is still awaiting their 2023 CAV results, but willing to share experience. Mesa County also had a CAV in 2023.

# b. MT-2 Forms—

- i. Denver identified the forms expired on 1/1/24
- ii. Marijo recommended use of the old forms, and to check FEMA website regularly for updates.
- iii. No updates on the FEMA website vet
- iv. Don't know when the new formwill come out
