- 1) MHFD News Christin MHFD
 - a) FFRMS
 - i) HUD 2ft rule, structures in 1% need to be 2ft about BFE to get a loan. Need to be elevated
 - ii) Question should MHFD change their ordinance to 2 ft?
 - 1. Will have conversations with communities.
 - 2. Is it worth to change it to 2ft?
 - iii) Laura FFRMS was repealed. Not federally mandated now. FEMA and HUD have it as part of their rules so they will roll with it, but it is not a mandate.

 - 1. Propose to modify the definition of the SFHA
 - (a) Flood Prone Areas change confidence limits from 50% to 95% + allowable rise (1/2 ft in CO) + other planned and possible increases
 - (b) Mandatory Purchase areas use future conditions for floodplain management
 - 2. Other recommendations discussed
 - 3. None have been adopted by FEMA yet
- b) NOAA Atlas 15
 - 1. Pilot Study recently released (9/26/24) includes Montana, Idaho and Wyoming
 - 2. Atlas 15 final in 2027
 - 3. Water.noaa.gov/about/atlast15/pilotvisualizationpage comments due by January 31, 2025
 - 4. How does the NOAA Atlas 15 Pilot differ from the recently released NOAA Atlas 14 Volume 12 study? The NOAA Atlas 15 Pilot study only covers the state of Montana, whereas the NOAA Atlas 14, Volume 12 study spans the states of Montana, Idaho, and Wyoming. Moreover, the NOAA Atlas 15 Pilot implements nonstationary statistical methods and uses climate model information to project precipitation frequency estimates into the future. In contrast, the NOAA Atlas 14, Volume 12 study assumes a stationary climate when deriving precipitation frequency estimates. Though NOAA is working to implement NOAA Atlas 15, the NOAA Atlas 14 studies (Volumes 1 12) are the existing national standard and authoritative source for precipitation frequency information today.

 - (a) New report released on June 18, 2024, "National Academies Modernizing PMP Estimation
